Description of activities

22.10.2021 Arrival in Lima

After arriving in Lima field work in Pucallpa, Ucayali was prepared. Therefore, several meetings with local CIAT staff (Maria Claudia) were held in local cafés. Due to the pandemic it was not possible to visit CIAT offices in Lima and meet more CIAT staff in person. Furthermore Zoom meetings were held with Jose Sanchez Choy, who is our main contact person from CIAT in Pucallpa and has been working with them in the Ucayali region for many years.

02.11.2021: Arrival in Pucallpa

During the stay in Pucallpa, a total of 15 interviews that are listed below were held. All interviews have been recorded to allow transcribing and a more detailed analysis of the data.

We held different types of interviews including in-depth interviews, Net-Map sessions as well as Q-sort sessions. The in depth-interviews were used to get a better picture of the cocoa value chain, allowing the preparation of the Net-Map and Q-Sort sessions. These sessions were prepared and held during our field stay. Most of the interviews were held in Pucallpa but travelling to Neshuya and Curimaná was required to interview farmers as well as staff of the respective cacao cooperation and association.

Several Zoom meetings with Dr. Christine Bosch and Dr. Jonathan Mockshell were held in between to discuss the progress made.

We were furthermore able to witness different workshops held by CIAT. One of them was held on 13.11.2021 in the hotel Manich in Pucallpa. Several stakeholders of not only the cacao value chain but also palm oil, were invited to discuss the joint vision of the sector.

On 16.11.2021 and 17.11.2021 we were able to participate in workshops held in the farmers' association Curimaná. The workshops aimed at learning about farmers perspectives and presenting the different sustainable agricultural practices that mitigate CO2 emissions.

On 19.11.2021 we were able to join a public auditory of the congress, were the agricultural chamber (CADU) and the technical roundtables presented the necessities needs of farmers and the problems in the cacao sector to politicians, followed by a public auditory.

30.11.2021: Travelling back to Lima

Back in Lima, the process of transcribing and coding the data using MAXQDA was started.

Interaction with local communities

The first contact with local farmers were made in the above mentioned workshop that was held by CIAT staff. The workshop was conducted to learn about farmers perspectives on zero deforestation and the relationship with cacao and to present sustainable agricultural practices that can lower CO2 emissions. Limitations and difficulties

After the first interviews I conducted with stakeholders of the multi-stakeholder platform (technical roundtable) it was realized that it will be difficult to base the research project only on the analyzation the multi-stakeholder platform as planned because it is not functioning as we expected it to do. Hence, we decided to select the cacao cooperative Colpa de Loros and the farmers' association Curimaná in order to have Net-Map sessions with them as well. This allows the comparison of challenges and success on different levels in the cacao value chain. The two organizations were selected because Colpa de Loros serve as a role model in the cacao sector in Ucayali and the association in Curimaná is less developed and faces more challenges. We furthermore faced the issue of absenteeism of all kind of stakeholders in all kind of activities. Starting from workshops that were given by CIAT, by us, or meetings of the multi-stakeholder platform.

Visiting CIAT office in Cali

10.12.2021 : Arrival in Bogotá

From Bogotá I travelled to Cali by bus, in order to meet my supervisor Jonathan Mockshell and to visit the CIAT campus in Cali. It was planned to have a presentation of preliminary results. This presentation was however postponed, because many of CIAT staff were on Christmas leave already.

During my day at CIAT I had the chance to discuss my findings with Dr. Jonathan Mockshell and to get insights into the day to day business of CIAT.

I furthermore had the chance to discuss my findings with Augusto Castro, who is the leader of low emissions food systems at CIAT and has been responsible for managing the funding of the project. It became clear that global narratives have a great influence on project design.

During my stay in Cali I also met Andres Charry, who has been working in the SAB project in Pucallpa. It was very insightful to get his personal opinion on the CIAT project and to discuss institutional and structural issues of the CIAT project with him.
